 3. Each party shall be at liberty to terminate this MOU with a written notice period of 30 (thirty) days / (1) month to the other party without any compensation and seeking legal redress.
 4. In case of termination of this MOU, SKILLSET agrees to fulfill their commitments towards the enrolled students and to complete the remaining training for the particular semester.
 5. All claims, disputes, differences or disagreements of whatsoever nature arising out of, in connection with or in relation to this MOU whether during its term or after expiry thereof or prior termination, shall be finally decided by arbitration to be held in accordance with the provisions of the Arbitration and Conciliation Act, 1996 in force as at the date of the invocation of the arbitration. Parties mutually agree to refer their disputes to the sole arbitration of a mutually agreed person, whose decision and award shall be final and binding between the Parties. The venue of arbitration shall be Secunderabad, Telangana.
 6. Courts in Secunderabad shall have exclusive jurisdiction to settle all disputes and differences arising out of this MOU, whether during its term or after expiry / earlier termination thereof.
 7. Both the Parties shall indemnify and hold each other harmless from and against any claim, loss, liability, or expense, including, but not limited to, damages, patent and trademark infringement, costs and attorneys' fees, arising out of or in connection with any acts or omissions of their agents or employees.
 8. Any notice/better/correspondence either through registered post/courier/fax shall be delivered /served at the business address of the Parties.
 9. Each Party shall bear its own legal, and other costs, charges and expenses connected with the negotiation, preparation and execution of this MOU or any other agreement incidental to or referred to in this MOU.
 10. This MOU may not be amended or modified except by an instrument in writing signed only by the authorized signatories on behalf of both the Parties. In witness whereof, both Parties put their hard seal on the day, month and year herein mentioned.
 11. Profiles of the entire concerned faculty in terms of their qualifications and experience shall be provided by SKILLSET and shall be agreed upon by MREM prior to start of training for a particular semester.
 12. SKILLSET should not depute faculty other than the ones approved by MREM.
 13. Professional ethics, code of conduct and disciplinary approach shall be maintained by SKILLSET faculty towards students at MREMs. Any misbehavior by SKILLSET

faculty shall attract immediate replacement of the concerned trainer.




14. Separate attendance register will be maintained by MREM and faculty from SKILLSET will have to sign the register after completion of each session.
15. Faculty from SKILLSET may be evaluated by senior faculty from MREM in terms of delivery and contents of the sessions. Appropriate written feedback will be provided to SKILLSET in case of improvement required. SKILLSET will take necessary steps to ensure that corrective actions are taken.
16. SKILLSET faculty will also be evaluated by students by way of "online/offline" feedback mechanism and minimum expected feedback is 7 (on a scale of 10).
17. Both the Parties may address the issue of providing joint participation / completion certificates to the enrolled students after successful completion of the program, if demanded by large number of students.
